# **SECTION III: NARRATIVE**

#### **BILL SUMMARY**

Synopsis: House Bill 480 (HB480) is an act that issues a standardized special registration plate with a logo designed to express support suicide prevention.

The owner would pay an initial \$35 dollar fee and a \$30-dollar annual renewal fee. Revenue from the fees imposed by shall be distributed as follows: (1) \$12 dollars of the initial fee collected for each registration plate shall be retained by the issuing department (2) the remaining portion of the initial fee and the entire renewal fee collected for each registration plate shall be distributed and appropriated to the Health Care Authority Behavioral Health Services Division (HCA/BHSD) to support suicide prevention efforts.

#### FISCAL IMPLICATIONS

There is no fiscal impact on HC /BHSD's existing budget. The bill provides a new minimal, revenue stream dedicated to suicide prevention efforts.

## **SIGNIFICANT ISSUES**

The NM suicide death rate decreased by 9% in 2023 compared to prior year. Additionally, the number of NM American Indian/Alaska Native residents who died by suicide decreased 43% compared to the prior year.
