SECTION III: NARRATIVE

BILL SUMMARY

House Bill 515 (HB515) makes an appropriation of one million five hundred thousand dollars (\$1,500,000) from the General Fund to the Board of Regents of Western New Mexico University (WNMU) for expenditure in Fiscal Year (FY) 2026 and FY27 to create and support a university men's baseball program.

FISCAL IMPLICATIONS

HB515 makes an appropriation of one million five hundred thousand dollars (\$1,500,000) from the General Fund to the WNMU Board of Regents for expenditure in FY26 and FY27. Any unexpended or unencumbered balance remaining at the end of FY27 reverts to the General Fund.

SIGNIFICANT ISSUES

HB515 makes an appropriation to WNMU to create and support a men's baseball program. WNMU currently does not have a men's baseball team. The funding in HB515 is for two years, so it presumably will support the initial costs for starting the program, including going towards equipment, staff, and facilities. It is unclear how WNMU will continue to financially support the men's baseball program if it is successful and continues after FY27.

HB515 supports the creation of a men's baseball program, but there is no mention of support for a women's baseball program.

HB515 does not stipulate that the new men's baseball program would include a competitive intercollegiate team, but, considering that WNMU has other competitive intercollegiate teams, it is conceivable that the intention is to build an competitive intercollegiate men's baseball team.

PERFORMANCE IMPLICATIONS

ADMINISTRATIVE IMPLICATIONS

WNMU will need staff to facilitate the creation and support of the new men's baseball program. It may be that the funding in HB515 will go towards those costs.

CONFLICT, DUPLICATION, COMPANIONSHIP, RELATIONSHIP

2024 House Bill 214 (HB214) proposed the same amount in an appropriation for FY25 and FY26 and for the same purpose, but it was postponed indefinitely.
