BILL SUMMARY

Synopsis:

Enacts new sections in the Health Care Purchasing Act, Health Maintenance Organization Law, Nonprofit Health Care Plan Law, Chapter 59A, Article 22 and Chapter 59A, Article 23 to ensure that "sensitive health care services" received by those under health insurance policies, health care plans, or certificates of insurance are not disclosed.

Defines "sensitive health care service" as "any health care service that is of a particularly sensitive and personal nature, including: (1) reproductive or sexual health care services; (2) genderaffirming health care services; (3) behavioral health care services; or (4) health care services related to treating a victim of domestic violence."

FISCAL IMPLICATIONS

State Health Benefits May impact some correspondence. Estimated cost is \$46,750.00. No additional SHB impact.

Medical Assistance Division

Medical Assistance Division would require updates to correspondence including remittance advice and letters generated by the claims system. Estimated cost is \$44,500.00.

SIGNIFICANT ISSUES

Abortion-related and gender affirming health care is a right in New Mexico under the Reproductive and Gender-Affirming Health Care Freedom Act and Reproductive and Gender-Affirming Health Care Freedom Protection Act. (NMSA Chapter 24, Articles 34 and 35). Such health care is not fully protected federally, and some states have passed laws declaring these health care services are illegal.

Consequentially, other states may seek to criminally prosecute New Mexico residents who have received these services in NM and are present in the other state. Other states may also attempt to prosecute people who travel to New Mexico to receive the services and are currently present or residing in the other state. By keeping health care information private, HB536 would help to protect people from criminal prosecution for receiving services that are legal and protected in New Mexico.
