SECTION III: NARRATIVE

BILL SUMMARY

Synopsis:

HB 540 establishes eligibility requirements and procedures to fill vacancies in the office of representative and in the office of senator. It requires boards of county commissioners to establish and follow procedures to fill legislative vacancies.

FISCAL IMPLICATIONS

SIGNIFICANT ISSUES

In order for individuals to be eligible for appointment, HB 540 requires that they live and be registered to vote in the district for which they are being appointed. They must have been registered to vote and have continuously resided in the district since the date of the secretary of state's proclamation for the most recent previous general election.

The date for the issuance of general election proclamations is addressed in 1-8-12 NMSA 1978 and is established as the last Monday in January of each even-numbered year.

Provisions for determining residency for candidates in New Mexico's elections are included in 1-1-7 NMSA 1978. "For the purpose of determining the residence of a person desiring to be a candidate for the nomination or election to an office under the provisions of the Election Code [Chapter 1 NMSA 1978] or for the purpose of determining the residence of any signer of a petition required by the Election Code, permanent residence shall be resolved in favor of that place shown on the person's certificate of registration as his permanent residence, provided the person resides on the premises."

Persons certified to be candidates in statewide elections in this state must be residents in the district of the office for which the person is seeking candidacy on the date of the secretary of state's proclamation for that election.
