BILL SUMMARY

Synopsis: This joint resolution proposes amending Art. 10, Section 2(D) of the New Mexico Constitution (Section 1). The amendment would remove the current term limits for county sheriffs. Under the current term limits, a person is limited to holding two consecutive four-year terms and then is ineligible to hold any county office for two years after. This amendment, if it passed a voter referendum, would eliminate this term limit for county sheriffs and allow them to serve unlimited terms for the office of sheriff.

Section 2 indicates that the amendment shall be submitted to the people for their approval or rejection at the next general election or any special election prior to that date.

SIGNIFICANT ISSUES

The bill is potentially confusing in that it does not address whether, if someone served in a non-sheriff capacity (e.g., as county commissioner) for two consecutive four-year terms and then wants to run for sheriff, they are precluded from doing so for two years after the expiration of their second term in the non-sheriff capacity. The most likely interpretation under the bill as written is that they would remain ineligible for two years.
