BILL SUMMARY

Creates the Behavioral Health Reform and Investment Act; directs creation of Behavioral Health regions (geographic area that encompasses one or more counties or judicial districts) in which behavioral health services will be provided—meaning an array of services for the treatment, rehabilitation, prevention and identification of mental illnesses and substance abuse—pursuant to a phased-in regional plan for the continuation and expansion of behavioral health services. The Administrative Office of the Courts (AOC) is charged with designating health regions, coordinating regional meetings, completing resource mapping and coordinating development of regional behavioral health plans; declares an emergency.
