Please send this email using the email address used in the registration process. Please note confirmation may take up to 24 hours; please register as soon as possible to avoid delays in the ability to upload analysis.

Once registered, you will have the ability to click on "Upload" where you will be prompted to "Select Agency" (select your agency from dropdown list) > "Bill" (select chamber) (select bill type) (type-in bill number) > Date > Choose File> Submit. The upload system will rename the file based on the information you provide, and the file will automatically become available to LFC analysts and prepared for posting on the website. The file MUST be in a PDF format.

Agencies must also use the LFC Agency Bill Analysis template, which is available on the Legislature's Website:

When saving files, save as a PDF.
