### **SECTION III: NARRATIVE**

#### **BILL SUMMARY**

##### Synopsis:

SB 65 would add consumer protections to homeowners purchasing residential solar energy systems by establishing the Consumer Solar Protection Act.

Section 1 of the Bill is the title of the Bill.

Section 2 of the Bill would provide definitions needed for subsequent sections of the Consumer Solar Protection Act.

Section 3 of the Bill would require sellers of residential solar energy systems to have and display required permits and prohibit them various actions and require them to give paper copies of electronic documents to the consumer upon request.

Section 4 of the Bill prohibits sellers from requesting or accepting payment, refusing to return payment, or reporting to a credit agency a missed payment for residential solar energy systems prior to them being operational, as well as prohibiting a finance contract holder from requesting or accepting payments after repurchase.

Section 5 of the Bill provides for a private right of action for violations of the Consumer Solar Protection Act.
