Synopsis:

SB118- Essentially identical to 2023 SB500 as substituted by SHPAC) Requires state agencies to provide a space on license application and renewal forms for the applicant to state a desire to make an anatomical gift. Directs the agency to transfer that information to the Motor Vehicle Division of TRD for incorporation into the donor registry it maintains under Section 66-5-10.
