#### **BILL SUMMARY**

Synopsis: Senate Bill 137 (SB137)

SB137 makes amendments to the current "Enhanced 911 Act" (Act), §§63-9D-1 to – 11.1 NMSA 1978, including shortening the name of the Act and well as similarly amending the name of the current "enhanced 911fund." Amendments and additions are made to a number of definitions of terms used in the Act. SB137 also raises the 911 emergency surcharge from fiftyone cents (\$.51) to one dollar fifty cents (\$1.50) to be billed to each subscriber access line by a communications service provider. SB137 also amends the procedure for adopting, amending or repealing the rules as provided in the State Rules Act, with additional publication requirements. If enacted, the bill would take effect July 1, 2025.

#### FISCAL IMPLICATIONS

There is no anticipated fiscal impact on the New Mexico Regulation and Licensing Department (RLD) if SB 137 were to be enacted.

The RLD does not provide a public safety answering point or 911 dispatch services. The RLD does not directly regulate or license any of the affected law enforcement, emergency medical or other professions impacted by SB 137. Likewise, none of the state licensing boards or commissions administratively attached to the RLD regulate or license any of the affected law enforcement, emergency medical or other professions dealt with under the bill.
