Section IV: Narrative

1. BILL SUMMARY

a) Synopsis

SB 199 would make changes to how the liquor tax funds available to the Department of Finance and Administration's Local DWI (LDWI) program are allocated. While the amount of liquor excise tax funds available to the program varies from year based on the total amount collected, some set asides are in set in statute, and SB 199 would change many of these amounts.

Importantly, it would increase the amount available for the LWDI Bureau at the Department of Finance and Administration for administration, technical support, and evaluation from \$600,000 to \$1.1 million.

b) Significant Issues

In 2023, twice as many New Mexicans died from alcohol than drug overdose (1,896 alcoholrelated deaths versus 948 drug overdose deaths). New Mexico has had the nation's highest rate of alcohol-related death for the past 30 years. Additionally, 21% of the deaths among working age New Mexicans (decedents aged 16-64) were due to alcohol in 2022. In 2018, the CDC ranked the leading causes of death in New Mexico, and six of those ten causes of death are partially attributable to alcohol, according to another CDC analysis. In 2023, 13.8% of New Mexicans drank excessively.

According to the National Institute of Alcohol Abuse and Alcoholism, and the CDC, alcoholrelated deaths are preventable.

The Local DWI (LDWI) program is a significant source of funding for addressing not only DWIs, but also alcohol misuse generally through its prevention and treatment activities. By funding programs at the county level, it is an important part of ensuring prevention and treatment are available throughout the state. Providing quality state-level programmatic support and evaluation for local activities is a significant component of ensuring their success.

Since 2003, the amount of funds the LDWI program distributes has increased significantly from \$11 million to \$22 million, while funding for administrative support at DFA's LWDI Bureau has remained at \$600,000. Increasing the funding for program support and administration will ensure that the LDWI Bureau can hire and retain the staff needed to provide sufficient support

for local activities and ensure that treatment and prevention interventions are implemented effectively. 2. 8. DISPARITIES ISSUES

In 2023 in New Mexico, American Indian/Alaska Natives (AIAN) died at an age-adjusted rate that is 3.7 times higher than the state overall. The age-adjusted rate of alcohol-related death among AIAN is 2.5 times higher than the age-adjusted rate of alcohol-related death among Hispanics – the group with the second highest age-adjusted rate of alcohol-related death in the state.

9. HEALTH IMPACT(S)

Increasing funding for program support and administration within the LDWI Bureau will improve hiring and retention of staff needed to provide sufficient support for local activities and ensure that treatment and prevention interventions are implemented effectively. Effective provision of program activities and treatment and prevention interventions ensures that local activities and prevention efforts are carried out in a timely and coordinated manner which can improve health outcomes stemming from successful prevention activities and implemented treatment interventions.
