SB224- Authorizes the Superintendent of Insurance to participate in any mediation process concerning a claim brought pursuant to the Medical Malpractice Act. Requires notice to the Superintendent of, and opportunity for the Superintendent to intervene in, any settlement in district court that may result in payment from the Patient’s Compensation Fund.
