SECTION III: NARRATIVE

BILL SUMMARY

<u>Synopsis:</u> Senate Bill 244 would make unlawfully transferring a firearm to a minor a criminal offense punishable as felony racketeering but provides numerous exemptions for hunting, sport shooting or other activities related to nonprofits and gun clubs.

Transferring a firearm to a minor would be added to the definition of racketeering under Sec. 30-42-3, punishable as a second-degree felony.

Exemptions include:

- attending a hunter's safety course or handgun safety course
- Target shooting at an established shooting range
- Competitive shooting
- A performance or practice related to a 501(c)3 nonprofit organization
- Legal hunting or trapping
- If the minor is on property under control of the minor's parents, grandparents or legal guardian and is being supervised by one of these adults
- The transfer occurs from the minor's parent, guardian or legal guardian to the minor.

FISCAL IMPLICATIONS

The New Mexico Corrections Department may face additional budgetary impacts, depending on the outcomes of successful prosecutions and the resulting sentences, whether involving prison terms or community supervision. At the FY24 expenditure level, the average cost per inmate is \$56,804 annually, or approximately \$156 per day. Given current trends in inflation and rising operational costs, the future average cost per inmate will exceed the current estimate. Additionally, the average annual cost per individual on community supervision is \$7,074.

Individuals convicted under this law may face longer sentences due to the felony racketeering charge.

SIGNIFICANT ISSUES

A standard condition of probation supervision is that the offender is not allowed to possess firearms or weapons. If the offender is convicted under this new law and placed on probation, the prohibition on weapon possession would apply, even if there are exceptions to the law for activities like hunting or sport shooting.
