SECTION III: NARRATIVE

BILL SUMMARY

Synopsis: SB261 creates the hub-and-spoke pilot project as a five-year pilot project in the department of health to deliver preventive health care services at public schools in underserved areas of the state; defining terms; providing for project goals and parameters; assigning duties; making an appropriation. One million seven hundred fifty thousand dollars (\$1,750,000) is appropriated from the general fund to the department of health for expenditure in fiscal years 2026 through 2030 to implement and administer the hub-and-spoke pilot project. It is estimated to be 350,000 per year. Any unexpended or unencumbered balance remaining at the end of fiscal year 2030 shall revert to the general fund.

SB 261 requires the Department of Health:

- Implement a pilot project in the northeast region with an FQHC in San Miguel County with at least 5 school districts.
- Contract with a FQHC
- Collect and Compile data
- Collaborate with the Public Health Department (PED)
- Provide periodic reports and a final report to the governor and legislature by November 1, 2030

FISCAL IMPLICATIONS

SB 261 appropriates one million seven hundred fifty thousand dollars (\$1,750,000) from the general fund to the department of health for expenditure in fiscal years 2026 through 2030 to implement and administer the hub-and-spoke pilot project.

Although appropriations are not directed to HCA, the pilot project criteria describe Medicaid enrolled providers therefore preventative services may be Medicaid reimbursable. Medicaid reimbursement would financially support the sustainability of the pilot project.

SIGNIFICANT ISSUES

PERFORMANCE IMPLICATIONS

If SB261 was enacted as written it has the potential to improve network adequacy and increase access for New Mexico Medicaid recipients to preventative services. The project may improve New Mexico Medicaid's performance in some Healthcare Effectiveness Data and Information Set (HEDIS) performance and participation in Well Child Visits.

ADMINISTRATIVE IMPLICATIONS

If SB261 was enacted as written it has the potential to require existing HCA staff resources to develop and implement additional policies, process and claims processing edits.

IT system edits required for this bill are anticipated to be completed at no additional cost.
