SECTION III: NARRATIVE

BILL SUMMARY

Senate Bill 290 proposes increasing the fee from twenty-five dollars to fifty dollars for issuing, acknowledging, and recording a marriage license and marriage certificate in New Mexico.

Senate Bill 290 states that the fifty-dollar fee will be deposited into the county clerk recording and filing fund. The fees collected will be remitted within the fifteen days of the last day of each month to each entity as follows:

- Fifteen dollars of each fee will be remitted to the county general fund.
- Fifteen dollars of each fee will be remitted to the state treasurer for credit to the children's trust fund
- Twenty dollars of each fee will be retained by the county clerk.

FISCAL IMPLICATIONS

No fiscal impact to Housing New Mexico | MFA.

SIGNIFICANT ISSUES

- 1. The increase in fees for marriage licenses will increase revenue for county clerks as they will now retain twenty dollars rather than ten dollars.
- 2. The increase in fees will allow for more administrative capacity of the county as fifteen dollars will be remitted to the county general funds.
- 3. The increase in fees may reduce the number of applications for marriage within counties due to the increased costs.
