## SECTION III: NARRATIVE

### BILL SUMMARY

SB 322 adds to 32A-2-4 Detention Facilities Standards. CYFD is statutorily obligated to certify the four existing detention homes in NM.

This measure amends 32A-2-4 by adding language to the statute regarding protocols for strip or body cavity searches.

Specifically, SB 322 requires that strip or body cavity searches only be performed if:

1) probable cause exists that there is dangerous contraband that could not otherwise be discovered and

2) the authorization to conduct this search would have to be with the permission of the Superintendent/ Director or designee.

It also requires that the least invasive means are utilized when performing a search and that an incident report regarding the search must be completed.

The measure also restricts cameras in the resident's shower or toilet area of a detention facility.

# FISCAL IMPLICATIONS

There would be no fiscal impact on CYFD if this measure were to be enacted. JJ has a full-time staff that provides the work to certify detention homes and CYFD can ensure this measure becomes part of the detention standards certification.

### SIGNIFICANT ISSUES

There is no significant issue to enact this bill as this requirement will be added to the existing protocols/procedures for searches.

### PERFORMANCE IMPLICATIONS

This function added to the JJ staff person would become another of the many required Detention Facility become certified. standards for a to It should be noted the JJ Correctional Facilities have very similar policies currently in place in regard to searches.
