#### **BILL SUMMARY**

#### Synopsis:

Senate Bill 349 appropriates funds from the general fund to the local government division of the Department of Finance and Administration for the North Central New Mexico Economic Development District. It allocates:

- 1. **\$2 million** for grants to public entities for housing planning and design.
- 2. **\$35 million** for grants to public entities for housing construction and infrastructure.

These funds are for fiscal year 2026 and beyond. Unused funds will not revert to the general fund, and administrative costs are capped at 10% of the appropriations.

# **FISCAL IMPLICATIONS**

#### SIGNIFICANT ISSUES

The bill positively impacts the North Central New Mexico Economic Development District:

By providing \$35 million for housing construction and infrastructure, the bill helps address housing shortages.

Investing in housing and infrastructure creates jobs in construction, engineering, and related industries, stimulating the local economy.

The \$2 million allocated for housing planning and design ensures that development projects are well thought out and sustainable.

Funding for infrastructure ensures that communities have the necessary utilities and services to support housing growth.

Public entities receive direct financial support to implement housing projects, reducing financial burdens on local governments and taxpayers.
