BILL SUMMARY

<u>Synopsis:</u> Senate Bill 395 appropriates one hundred thousand (\$100,000) to the New Mexico Tourism Department (NMTD) to expend on the Special Olympics in fiscal years 2025 and 2026.

FISCAL IMPLICATIONS

Senate Bill 395 appropriates \$100,000 to NMTD, which will be used in support of events produced by Special Olympics and will be expended in FY25 and FY26. Any unexpended or unencumbered funds at the end of FY26 will revert to the general fund.

SIGNIFICANT ISSUES

Historically, NMTD has provided support for Special Olympics through recurring and non-recurring appropriations. In FY25, NMTD is supporting Special Olympics in amount of \$650,000. The breakdown of the funding is as follows:

Recurring appropriations:

Chapter 140, Section 12, Item B of the New Mexico Laws of 2021, the New Mexico Legislature appropriated to NMTD a recurring one hundred thousand dollars (\$100,000) for branded partnerships between New Mexico True and the Special Olympics.

Chapter 3, Section 13, Item A2 of the New Mexico Laws of 2022, the New Mexico Legislature appropriated to NMTD a recurring two hundred fifty thousand dollars (\$250,000) for branded partnerships between New Mexico True and the Special Olympics

Non-recurring appropriation:

Chapter 69, Section 5, Item 72 of the New Mexico Laws of 2024, the New Mexico Legislature awarded NMTD a special appropriation of an additional three hundred thousand dollars (\$300,000) for athletic competitions for people with disabilities.

In both the Legislative Finance Committee (LFC) and Executive recommendations there is a non-recurring appropriation of \$300,000. As such without this bill, the funding available in FY26 to support Special Olympics of New Mexico will be \$650,000.
