#### **BILL SUMMARY**

Synopsis: Senate Bill 451 ("SB451") proposes to add language regarding minimum building code requirements to NMSA 1978, Section 60-13-9, which outlines the duties of the Construction Industries Division of the Regulation and Licensing Department (the "CID"). This new language would require that within two years of the International Code Council revising its International Building Codes, building codes adopted by the CID would meet the standards set forth in that revision. This would be the case for codes without other recommendations from the electrical, mechanical, or general constructions trade bureaus as outlined by NMSA 1978, Section 60-13-44.

#### SIGNIFICANT ISSUES

SB451 could effectively delegate the duties of the Construction Industries Division to adopt building codes to a separate body without deference to CID's discretion to adopt building codes through the use of the compulsory "shall." Issues could arise should the International Code Council adopt codes CID believes are contrary to its duties, or if the International Code Council ceases to exist at some point in the future.
