#### **SECTION III: NARRATIVE**

#### **BILL SUMMARY**

Synopsis:

Senate Bill 461 establishes an Equity and Excellence in Education Task Force, which will operate from July 1, 2025, to July 1, 2029. The bill allows the task force to review New Mexico's public education system, the Yazzie/Martinez lawsuit, and how state and federal funds are used. The bill also proposes that the task force complete studies and make proposed recommendations regarding education, workforce preparation, and collaboration across sectors. The bill appropriate \$250,000 to fund the task force.

# FISCAL IMPLICATIONS

No fiscal impact to IAD, however, the bill appropriates \$250,000 from the public education reform fund to the equity and excellence in education fund.

#### SIGNIFICANT ISSUES

The Indian Education Act, the Indian Education Division, and the Native American Education Advisory Council already address many, if not all, of the items stated in the bill. Creating a task force risks duplicative efforts without adding significant new value, particularly as tribal consultation and input mechanisms already exist in current frameworks. Rather, fully funding PED would likely prove most useful.
