BILL SUMMARY

Synopsis:

This bill proposes an appropriation of \$33 million from the state's general fund to the local government division of the Department of Finance and Administration. This funding is designated for fiscal year 2026 to establish a tribal liaison program in each county. The programs will offer nonpartisan services, including voter education and awareness initiatives, translation assistance, and voter registration drives. Any funds that remain unexpended or unencumbered by the end of fiscal year 2026 are set to revert to the general fund.

FISCAL IMPLICATIONS

This bill does include an appropriation of \$33,000,000.00 from the state general fund to the DFA Local Government Division. This bill does not contain any appropriations for the New Mexico Indian Affairs Department, as a result there is no fiscal impact to the New Mexico Indian Affairs Department.
