#### **BILL SUMMARY**

#### Synopsis:

This bill proposes revisions to New Mexico state law to establish Election Day as a paid holiday and expand voting rights for state and public employees, as opposed to allows up to two hours of voting time. The bill will require state and public employers to provide full-day compensation to employees who are absent to vote on Election Day.

Second, the bill adds Election Day to the list of official legal public holidays in New Mexico, alongside other recognized holidays like Independence Day and Thanksgiving. The bill exempts for certain employees, such as those with the Secretary of State, local governments, and Indian nations, tribes, pueblos, or law enforcement.

Employers who refuse to comply with these provisions could face misdemeanor charges and fines ranging from \$50 to \$100.

#### FISCAL IMPLICATIONS

IAD, like all other agencies, would be required to pay a full day salary/wage to all employees for the holiday.

#### SIGNIFICANT ISSUES

IAD supports the exemption of Indian Nations, Tribes, and Pueblos in this legislation as, generally, state legislation does not apply to Nations, Pueblos, and Tribes.
