### **BILL SUMMARY**

SM1 is requesting the Crime Victims Reparation Commission to convene a statewide gun violence prevention task force to study gun violence in NM and to make recommendations.

It also requests the participation of the Public Education Department, Higher Education Department, Department of Public Safety, CYFD, DOH, HCA, UNM, Game and Fish, Indian nations, tribes and pueblos of New Mexico, pueblo, local, and federal law enforcement agencies, gun advocates and distributors, and anti-domestic violence and sexual assault groups.

### FISCAL IMPLICATIONS

#### SIGNIFICANT ISSUES

There are many reasons to convene a task force to study the problem of gun violence, which impacts all New Mexicans. Guns on school grounds and shootings involving youth are frequent occurrences.

CYFD, particularly the Juvenile Justice division, would participate in this task force. The intention of the task force is to identify strategies and policies

that could help reduce gun violence and enhance public safety. Furthermore, this task force could bring diverse members of our communities together to look closely at this serious issue.
