BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. APPROPRIATION. --

Any unexpended or unencumbered balance remaining at the end of fiscal year 2026 shall revert to the general fund.

STBTC→B. The appropriation provided in Subsection A of this section shall provide for:

- (1) the statewide expansion of high-quality workforce development opportunities for persons released from the custody of a correctional facility or a jail in the state, based on an estimate of the number of persons likely to be released from custody each year;
- (2) with respect to released persons, intensive parallel case management, peer mentoring and resource navigation, all of which are intended to result in reduced recidivism, increased employment longevity and the prevention of homelessness;

(4) funding to be disbursed regionally throughout the state based on location release data for persons released from custody and on performance and evaluation indicators related to programs for released persons that align with the standards set in the federal Workforce Innovation and Opportunity Act standards.
