17	"30-20-16. BOMB SCARES AND SHOOTING THREATS UNLAWFUL
18	A. Making a bomb scare consists of falsely and
19	maliciously stating to another person that a bomb or other
20	explosive has been placed in such a position that property or
21	persons are likely to be injured or destroyed.
22	B. Making a shooting threat consists of
23	intentionally communicating to another person an intent to
24	bring a firearm to a property or use the firearm with the

1 (1) place a person or group of persons in fear 2 of great bodily harm; 3 (2) prevent or interrupt the occupation or use 4 of a public building; or 5 cause a response to the threat by a law (3) 6 enforcement official or volunteer agency organized to deal with 7 emergencies. Whoever commits making a bomb scare is guilty of 8 C. 9 a fourth degree felony. 10 Whoever commits making a shooting threat is D. 11 guilty of a [misdemeanor] fourth degree felony. 12 A court may order a person convicted for the Ε. 13 offense of making a bomb scare or shooting threat to reimburse 14 the victim of the offense for economic harm caused by that 15 offense. 16 As used in this section, "economic harm" means F. 17 all direct, incidental and consequential financial harm 18 suffered by a victim of the offense of making a bomb scare or 19 shooting threat. "Economic harm" includes: 20 (1) wages, salaries or other compensation lost 21 as a result of the commission of the offense of making a bomb 22 scare or shooting threat; 23 the cost of all wages, salaries or other (2)24 compensation paid to employees for time that those employees 25 are prevented from working as a result of the commission of the .229074.1 - 2 -
