17	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
18	SECTION 1. A new section of Chapter 21 NMSA 1978 is
19	enacted to read:
20	"[ <u>NEW MATERIAL</u> ] STATE EDUCATIONAL INSTITUTIONSBOARDS OF
21	REGENTS MANDATORY TRAINING
22	A. The members of the boards of regents of all
23	state educational institutions enumerated in Article 12,
24	Section 11 of the constitution of New Mexico shall complete ten
25	hours of training during the first year of the members' terms.

1 The training shall consist of: 2 two hours covering the provisions of the (1)3 constitution of New Mexico and state law pertaining to state educational institutions and related post-secondary education 4 5 matters; 6 (2) two hours covering financial management, 7 budgeting and fiduciary duties; 8 (3) two hours covering student success and 9 student support services; 10 (4) two hours covering institutional 11 governance, innovation, best practices and available federal, 12 state and nongovernmental resources to assist the boards of 13 regents and members of the boards; and 14 two hours covering ethics and state law (5) 15 regarding ethics oversight and public accountability, including 16 the Procurement Code, the Open Meetings Act and the Inspection 17 of Public Records Act. 18 Β. The higher education department shall develop 19 and provide the ten hours of training." 20 **SECTION 2.** APPLICABILITY.--The provisions of this act 21 apply to all members appointed to the boards of regents of the 22 state educational institutions enumerated in Article 12, 23 Section 11 of the constitution of New Mexico after the 24 effective date of this act and to current members with at least 25 one year of the members' terms left to be served after the .228592.5
