PURPOSE

1 2 It is the purpose of the Interstate Compact on Educational 3 Opportunity for Military Children to remove barriers to 4 educational success imposed on children of military families 5 because of frequent moves and deployment of their parents by: 6 Α. facilitating the timely enrollment of children 7 of military families and ensuring that they are not placed at a 8 disadvantage due to difficulty in the transfer of education 9 records from the previous school district or variations in 10 entrance and age requirements; 11 Β. facilitating the student placement process 12 through which children of military families are not 13 disadvantaged by variations in attendance requirements, 14 scheduling, sequencing, grading, course content or assessment; 15 facilitating the qualification and eligibility C. 16 for enrollment, educational programs and participation in 17 extracurricular, academic, athletic and social activities; 18 D. facilitating the on-time graduation of children 19 of military families; 20 providing for the promulgation and enforcement Ε. 21 of administrative rules implementing the provisions of that 22 compact; 23 F. providing for the uniform collection and sharing 24 of information between and among member states, schools and 25 military families under that compact; .229784.1

1 G. promoting coordination between that compact and 2 other compacts affecting military children; and 3 promoting flexibility and cooperation between н. the educational system, parents and the student in order to 4 achieve educational success for the student. 5 6 ARTICLE 2 7 DEFINITIONS 8 As used in the Interstate Compact on Educational 9 Opportunity for Military Children: 10 "active duty" means full-time duty status in the Α. 11 active uniformed service of the United States, including 12 members of the national guard and reserve on active duty orders 13 pursuant to 10 U.S.C. [Sections] Chapters 1209 and 1211; 14 Β. "children of military families" means school-15 aged children enrolled in kindergarten through twelfth grade in 16 the household of an active duty member; 17 "compact commissioner" means the voting C. 18 representative of each compacting state appointed pursuant to 19 Article 8 of the Interstate Compact on Educational Opportunity 20 for Military Children; 21 "deployment" means the period one month prior to D. 22 the service members' departures from their home stations on 23 military orders through six months after return to their home 24 stations; 25 "education records" means records, files and Ε. .229784.1

data that are directly related to a student and maintained by a school or local education agency, including records encompassing all the material kept in a student's cumulative folder such as general identifying data, records of attendance and of academic work completed, records of achievement and results of evaluative tests, health data, disciplinary status, test protocols and individualized education programs;

F. "extracurricular activity" means a voluntary activity sponsored by a school or local education agency or an organization sanctioned by a local education agency. "Extracurricular activity" includes preparation for and involvement in public performances, contests, athletic competitions, demonstrations, displays and club activities;

G. "interstate commission" means the interstate commission on educational opportunity for military children that is created under Article 9 of the Interstate Compact on Educational Opportunity for Military Children;

H. "local education agency" means a public authority legally constituted by the state as an administrative agency to provide control of and direction for kindergarten through twelfth grade public educational institutions;

I. "member state" means a state that has enacted the Interstate Compact on Educational Opportunity for Military Children;

J. "military installation" means a base, camp, .229784.1

1 this article, the Interstate Compact on Educational Opportunity 2 for Military Children shall apply to the children of: 3 active duty members of the uniformed (1) 4 services, including members of the national guard and reserve 5 on active duty orders pursuant to 10 U.S.C. [Sections] Chapters 6 1209 and 1211; 7 members or veterans of the uniformed (2) services who are severely injured and medically discharged or 8 9 retired for a period of one year after medical discharge or 10 retirement; and 11 (3) members of the uniformed services who die 12 on active duty or as a result of injuries sustained while on 13 active duty and extending for a period of one year after death. 14 Β. The provisions of the Interstate Compact on 15 Educational Opportunity for Military Children shall only apply 16 to local education agencies. 17 C. ARTICLE 4

EDUCATIONAL RECORDS AND ENROLLMENT

A. In the event that official education records cannot be released to the parents for the purpose of transfer, the custodian of the records in the sending state shall prepare and furnish to the parent a complete set of unofficial education records containing uniform information as determined by the interstate commission. Upon receipt of the unofficial education records by a school in the receiving state, the school shall enroll and appropriately place the student based on the information provided in the unofficial records, pending validation by the official records, as quickly as possible.

B. Simultaneous with the enrollment and conditional placement of the student, the school in the receiving state shall request the student's official education record from the school in the sending state. Upon receipt of this request, the school in the sending state shall process and furnish the official education records to the school in the receiving state within ten days or within such time as is reasonably determined under the rules promulgated by the interstate commission.

the date of enrollment or within such time as is reasonably determined under the rules promulgated by the interstate commission for students to obtain any immunizations required by the receiving state. For a series of immunizations, initial vaccinations must be obtained within thirty days or within such time as is reasonably determined under the rules promulgated by the interstate commission.

8 Students shall be allowed to continue their D. 9 enrollment at a grade level in the receiving state commensurate 10 with their grade level, including kindergarten, from a local 11 education agency in the sending state at the time of 12 transition, regardless of age. A student that has 13 satisfactorily completed the prerequisite grade level in the 14 local education agency in the sending state shall be eligible 15 for enrollment in the next highest grade level in the receiving 16 state, regardless of age. A student transferring after the 17 start of the school year in the receiving state shall enter the 18 school in the receiving state on the student's validated level 19 from an accredited school in the sending state.

ARTICLE 5

PLACEMENT AND ATTENDANCE

A. When a student transfers before or during the school year, the receiving state school shall initially honor placement of the student in educational courses based on the student's enrollment in the sending state school or educational .229784.1 -9 -

1 assessments conducted at the school in the sending state if the 2 courses are offered. Course placement includes honors, 3 international baccalaureate, advanced placement, vocational, 4 technical and career pathways courses. Continuing the 5 student's academic program from the previous school and promoting placement in academically and career-challenging 6 7 courses should be paramount when considering placement. This 8 subsection does not preclude the school in the receiving state 9 from performing subsequent evaluations to ensure appropriate 10 placement and continued enrollment of the student in the 11 courses.

B. The receiving state school shall initially honor placement of the student in educational programs based on current educational assessments conducted at the school in the sending state or participation or placement in like programs in the sending state. Such programs include gifted and talented programs and English as a second language. This subsection does not preclude the school in the receiving state from performing subsequent evaluations to ensure appropriate placement of the student.

C. In compliance with the federal requirements of the Individuals with Disabilities Education Act, 20 U.S.C. Section 1400 et seq., the receiving state shall initially provide comparable services to a student with disabilities based on the student's current individualized education .229784.1

program. In compliance with the requirements of Section 504 of the Rehabilitation Act of 1973, 29 U.S.C. Section 794, and with Title II of the Americans with Disabilities Act of 1990, 42 U.S.C. Sections 12131-12165, the receiving state shall make reasonable accommodations and modifications to address the needs of incoming students with disabilities, subject to an existing 504 or Title II plan, to provide the student with equal access to education. This subsection does not preclude the school in the receiving state from performing subsequent evaluations to ensure appropriate placement of the student.

D. Local education agency administrative officials shall have flexibility in waiving course or program prerequisites or other preconditions for placement in courses or programs offered under the jurisdiction of the local education agency.

E. A student whose parent or legal guardian is an active duty member of the uniformed services and has been called to duty for, is on leave from or has immediately returned from deployment to a combat zone or combat support posting shall be granted additional excused absences, at the discretion of the local education agency superintendent, to visit with the student's parent or legal guardian.

ARTICLE 6

ELIGIBILITY

guardianship of a child of a military family and executed under applicable law, shall be sufficient for the purposes of enrollment and all other actions requiring parental participation and consent.

B. A local education agency shall be prohibited from charging local tuition to a military child who is in transition and is placed in the care of a noncustodial parent or other person standing in loco parentis who lives in a jurisdiction other than that of the custodial parent.

C. A military child who is in transition and is placed in the care of a noncustodial parent or other person standing in loco parentis who lives in a jurisdiction other than that of the custodial parent may continue to attend the school in which the child was enrolled while residing with the custodial parent.

D. State and local education agencies shall facilitate the opportunity for transitioning military children's inclusion in extracurricular activities, regardless of application deadlines, to the extent they are otherwise qualified.

ARTICLE 7

GRADUATION

In order to facilitate the on-time graduation of children of military families, states and local education agencies shall incorporate the following procedures:

1 Α. local education agency administrative officials 2 shall waive specific courses required for graduation if similar 3 course work has been satisfactorily completed in another local 4 education agency or shall provide reasonable justification for 5 denial. If a waiver is not granted to a student who would qualify to graduate from the sending school, the local 6 7 education agency shall provide an alternative means of 8 acquiring required coursework so that graduation may occur on 9 time;

B. receiving states shall accept exit or end-ofcourse exams required for graduation from the sending state, national norm-referenced achievement tests or alternative testing in lieu of testing requirements for graduation in the receiving state. In the event the alternatives in this subsection and Subsection A of this article cannot be accommodated by the receiving state for a student transferring in the student's senior year, then the provisions of Subsection C of this article shall apply; and

C. if a military student transferring at the beginning of or during the military student's senior year is ineligible to graduate from the receiving local education agency after all alternatives have been considered, the sending and receiving local education agencies shall ensure the receipt of a diploma from the sending local education agency if the student meets the graduation requirements of the sending local .229784.1

education agency. In the event that one of the states in question is not a member of the Interstate Compact on Educational Opportunity for Military Children, the member state shall use best efforts to facilitate the on-time graduation of the student in accordance with Subsections A and B of this article.

ARTICLE 8

STATE COORDINATION

Each member state shall, through the creation of Α. a state council or use of an existing body or board, provide for the coordination among its agencies of government, local education agencies and military installations concerning the state's participation in and compliance with the Interstate Compact on Educational Opportunity for Military Children and interstate commission activities. While each member state may determine the membership of its own state council, its membership must include: the secretary of public education, the superintendent of a school district with a high concentration of military children, one representative from a military installation, one representative from the executive branch of government and other offices and stakeholder groups the state council deems appropriate. A member state that does not have a school district deemed to contain a high concentration of military children may appoint a superintendent from another school district to represent local education .229784.1

The state council of each member state shall Β. appoint or designate a military family education liaison to assist military families and the state in facilitating the implementation of the Interstate Compact on Educational Opportunity for Military Children.

C. The compact commissioner responsible for the 8 administration and management of the state's participation in the Interstate Compact on Educational Opportunity for Military Children shall be appointed by the governor or as otherwise determined by each member state.

The compact commissioner and the military family D. education liaison designated in this article shall be exofficio nonvoting members of the state council, unless either is already a full voting member of the state council.

ARTICLE 9

INTERSTATE COMMISSION ON EDUCATIONAL OPPORTUNITY FOR MILITARY CHILDREN

The member states hereby create the "interstate commission on educational opportunity for military children". The activities of the interstate commission are the formation of public policy and are a discretionary state function. The interstate commission shall:

Α. be a body corporate and joint agency of the member states and shall have all the responsibilities, powers .229784.1 - 15 -

and duties set forth in the Interstate Compact on Educational Opportunity for Military Children and such additional powers as may be conferred upon it by a subsequent concurrent action of the respective legislatures of the member states in accordance with the terms of that compact;

B. consist of one voting representative from each member state who shall be that state's compact commissioner.

(1) Each member state represented at a meeting of the interstate commission is entitled to one vote.

10 (2) A majority of the total member states
11 shall constitute a quorum for the transaction of business,
12 unless a larger quorum is required by the bylaws of the
13 interstate commission.

(3) A representative shall not delegate a vote to another member state. In the event the compact commissioner is unable to attend a meeting of the interstate commission, the governor or state council may delegate voting authority to another person from the person's state for a specified meeting.

(4) The bylaws may provide for meetings of the interstate commission to be conducted by telecommunication or electronic communication;

C. consist of ex-officio nonvoting representatives who are members of interested organizations. The ex-officio members, as defined in the bylaws, may include members of the representative organizations of military family advocates, .229784.1

local education agency officials, parent and teacher groups, 2 the United States department of defense, the education 3 commission of the states, the interstate agreement on qualification of educational personnel and other interstate compacts affecting the education of children of military members;

meet at least once each calendar year. D. The chair may call additional meetings and, upon the request of a simple majority of the member states, shall call additional meetings;

Ε. establish an executive committee whose members shall include the officers of the interstate commission and such other members of the interstate commission as determined by the bylaws. Members of the executive committee shall serve a one-year term. Members of the executive committee shall be entitled to one vote each. The executive committee shall have the power to act on behalf of the interstate commission, with the exception of rulemaking, during periods when the interstate commission is not in session. The executive committee shall oversee the day-to-day activities of the administration of the compact, including enforcement and compliance with the provisions of the compact, its bylaws and rules and other such duties as deemed necessary. The United States department of defense shall serve as an ex-officio nonvoting member of the executive committee;

1 F. establish bylaws and rules that provide for 2 conditions and procedures under which the interstate commission shall make its information and official records available to 3 4 the public for inspection or copying. The interstate 5 commission may exempt from disclosure information or official 6 records to the extent they would adversely affect personal 7 privacy rights or proprietary interests;

give public notice of all meetings and all G. meetings shall be open to the public, except as set forth in the rules or as otherwise provided in the Interstate Compact on Educational Opportunity for Military Children. The interstate commission and its committees may close a meeting, or a portion of a meeting, if it determines by a two-thirds' vote that an open meeting would be likely to:

(1) relate solely to the interstate 16 commission's internal personnel practices and procedures;

disclose matters specifically exempted (2) from disclosure by federal and state statute;

(3) disclose trade secrets or commercial or financial information that is privileged or confidential;

involve accusing a person of a crime or (4) formally censuring a person;

disclose information of a personal nature (5)if the disclosure would constitute a clearly unwarranted invasion of personal privacy;

(6) disclose investigative records compiled for law enforcement purposes; or

(7) specifically relate to the interstate commission's participation in a civil action or other legal proceeding;

H. cause its legal counsel or designee to certify that a meeting may be closed and shall reference each relevant exemptible provision for any meeting, or portion of a meeting, that is closed pursuant to this subsection. The interstate commission shall keep minutes that shall fully and clearly describe all matters discussed in a meeting and shall provide a full and accurate summary of actions taken, and the reasons for the actions, including a description of the views expressed and the record of a roll call vote. All documents considered in connection with an action shall be identified in the minutes. All minutes and documents of a closed meeting shall remain under seal, subject to release by a majority vote of the interstate commission;

I. collect standardized data concerning the educational transition of the children of military families under the Interstate Compact on Educational Opportunity for Military Children as directed through its rules, which shall specify the data to be collected, the means of collection and data exchange and reporting requirements. The methods of data collection, exchange and reporting shall, insofar as is .229784.1 - 19 - reasonably possible, conform to current technology and coordinate its information functions with the appropriate custodian of records as identified in the bylaws and rules; and

4 J. create a process that permits military 5 officials, education officials and parents to inform the 6 interstate commission if and when there are alleged violations 7 of the Interstate Compact on Educational Opportunity for 8 Military Children or its rules or when issues subject to the 9 jurisdiction of the compact or its rules are not addressed by 10 the state or local education agency. This subsection shall not be construed to create a private right of action against the 11 12 interstate commission or any member state.

ARTICLE 10

POWERS AND DUTIES OF THE INTERSTATE COMMISSION The interstate commission may:

provide for dispute resolution among member Α. states;

promulgate rules and take all necessary actions Β. to effect the goals, purposes and obligations as enumerated in the Interstate Compact on Educational Opportunity for Military Children. The rules shall be binding in the compact states to the extent and in the manner provided in that compact;

C. issue, upon request of a member state, advisory opinions concerning the meaning or interpretation of the interstate compact and its bylaws, rules and actions; .229784.1

C. The executive committee shall have such authority and duties as may be set forth in the bylaws, including:

ARTICLE 14

FINANCING OF THE INTERSTATE COMMISSION

A. The interstate commission shall pay or provide for the payment of the reasonable expenses of its establishment, organization and ongoing activities.

B. The interstate commission may levy on and collect an annual assessment from each member state to cover the cost of the operations and activities of the interstate commission and its staff that must be in a total amount sufficient to cover the interstate commission's annual budget as approved each year. The aggregate annual assessment amount shall be allocated based upon a formula to be determined by the interstate commission, which shall promulgate a rule binding upon all member states.

C. The interstate commission shall not incur obligations of any kind prior to securing the funds adequate to meet the obligations; nor shall the interstate commission pledge the credit of any of the member states, except by and with the authority of the member state.

D. The interstate commission shall keep accurate accounts of all receipts and disbursements. The receipts and disbursements of the interstate commission shall be subject to the audit and accounting procedures established under its bylaws. However, all receipts and disbursements of funds handled by the interstate commission shall be audited yearly by .229784.1

Once effective, the Interstate Compact on Educational Opportunity for Military Children shall continue in force and remain binding upon each and every member state, provided that a member state may withdraw from that compact by specifically repealing the statute that enacted that compact into law.

B. Withdrawal from the Interstate Compact on Educational Opportunity for Military Children shall be by the enactment of a statute repealing that compact.

C. The withdrawing state shall immediately notify the chair of the interstate commission in writing upon the introduction of legislation repealing the Interstate Compact on Educational Opportunity for Military Children in the withdrawing state. The interstate commission shall notify the other member states of the withdrawing state's intent to withdraw within sixty days of its receipt of the notice.

D. The withdrawing state is responsible for all assessments, obligations and liabilities incurred on its behalf through the effective date of withdrawal, including obligations the performance of which extends beyond the effective date of withdrawal.
