9	A. Embezzlement consists of a person embezzling or
10	converting to the person's own use anything of value, with
11	which the person has been entrusted, with fraudulent intent
12	to deprive the owner thereof.
13	B. Whoever commits embezzlement when the value of
14	the thing embezzled or converted is two hundred fifty dollars
15	(\$250) or less against any one victim in any consecutive
16	twelve-month period is guilty of a petty misdemeanor.
17	C. Whoever commits embezzlement when the value of
18	the thing embezzled or converted is over two hundred fifty
19	dollars (\$250) but not more than five hundred dollars (\$500)
20	against any one victim in any consecutive twelve-month period
21	is guilty of a misdemeanor.
22	D. Whoever commits embezzlement when the value of
23	the thing embezzled or converted is over five hundred dollars
24	(\$500) but not more than two thousand five hundred dollars
25	(\$2,500) against any one victim in any consecutive

1	twelve-month period is guilty of a fourth degree felony.	
2	E. Whoever commits embezzlement when the value of	
3	the thing embezzled or converted is over two thousand	
4	five hundred dollars (\$2,500) but not more than	
5	twenty thousand dollars (\$20,000) against any one victim in	
6	any consecutive twelve-month period is guilty of a	
7	third degree felony.	
8	F. Whoever commits embezzlement when the value of	
9	the thing embezzled or converted exceeds twenty thousand	
10	dollars (\$20,000) against any one victim in any consecutive	
11	twelve-month period is guilty of a second degree felony."
