SUMMARY

Synopsis of HAAWRC Substitute for House Bill 34

The House Agriculture, Acequias and Water Resources Committee substitute for House Bill 34 (HB34) changes the statute governing the Oil Conservation Division (OCD) of the Energy, Minerals and Natural Resources Department (EMNRD to add language that would require OCD to protect the state's public health and environment.

This bill does not contain an effective date and, as a result, would go into effect 90 days after the Legislature adjourns if enacted, or June 20, 2025.

FISCAL IMPLICATIONS

The fiscal impact of HB34 would come from adding new levels of environmental and health review to the OCD's existing review process. This new review process would potentially duplicate work that the Air Quality Bureau of the Department of Environment is already tasked with doing. However, this duplication is not guaranteed, due predominantly to the fact that the bill does not specify what it means by "public health" or "environment" or how OCD would further protect both. EMNRD notes, if the intent of the language in the bill is to add an additional

level of environmental and health review on top of OCD's current review process, this bill could create significant burdens on staff time and agency resources. EMNRD did not quantify the budgetary impact of an additional level of review. Legislative Finance Committee staff estimate that, if the language did require OCD to add an additional level of environmental and health review, OCD would need 10 additional FTE, increasing division staffing costs by approximately \$1.2 million.

SIGNIFICANT ISSUES

EMNRD notes that HB34's lack of definitions for "public health" or "environment" creates uncertainty as to how existing OCD operations should be modified to meet the intentions of the bill.
