## SUMMARY

### Synopsis of House Joint Resolution 2

House Joint Resolution 2 proposes an amendment to Article IV, Section 22, of the state constitution to eliminate the governor’s pocket veto. Under the current provision, the governor must approve bills presented during the last three days of a session within 20 days after the Legislature adjourns. If the governor does not approve a bill within the required 20 days, the bill does not become a law. HJR2 amends the provision to require bills presented to the governor during the last three days of the session to be approved or vetoed within 20 days after adjournment. Unless vetoed within the required 20 days, the bill becomes a law. HJR2 also requires the governor to provide an explanation for every bill vetoed in whole or in part. Currently, the constitution only requires the governor to explain bills that are vetoed while the Legislature is in session.

## **FISCAL IMPLICATIONS**

Under Section 1-16-4 NMSA 1978 and the New Mexico Constitution, the Secretary of State (SOS) is required to print samples of the text of each constitutional amendment in both Spanish and English in an amount equal to 10 percent of the registered voters in the state. SOS is required to publish the samples once a week for four weeks preceding the election in newspapers in every county in the state. Further, the number of constitutional amendments on the ballot may impact the ballot page size or cause the ballot to be more than one page, also increasing costs. The estimated cost per constitutional amendment is \$35 thousand to \$50 thousand, depending on the size and number of ballots and if additional ballot stations are needed.

Should this proposed constitutional amendment be approved by voters, a cost that is indeterminate but minimal may impact the Office of the Governor if additional support is needed to review bills passed by the Legislature and prepare veto messages as applicable.

## **SIGNIFICANT ISSUES**

As shown in the attached table prepared by the Legislative Council Service, 160 bills have been vetoed between 2014 and 2024.
