## **SUMMARY**

#### Synopsis of Senate Bill 346

Senate Bill 346 (SB346) makes 26 appropriations totaling \$14 million from the general fund to the Department of Finance and Administration, Aging and Long-Term Services Department, Public Education Department, Higher Education Department, New Mexico State University, Eastern New Mexico University, and New Mexico Military Institute for the purpose of programmatic support for various local government programs, capital improvements, and purchase of equipment for the benefit of various local and state entities. The funds are appropriated for expenditure in FY25 and FY26.

This bill does not contain an effective date and, as a result, would go into effect 90 days after the Legislature adjourns if enacted, or June 20, 2025.

#### FISCAL IMPLICATIONS

The appropriations totaling \$14 million contained in this bill are nonrecurring expenses to the general fund. Any unexpended or unencumbered balances remaining at the end of FY26 shall revert to the general fund.

### SIGNIFICANT ISSUES

SB346 makes appropriations to local public entities for capital expenses and programmatic support, which would be administered through state agencies. The appropriations included in the
