7 Mexico residents have access to safe, high-quality housing and
8 commercial buildings while promoting home ownership across the

19 Mexico home builders association, the building contractors
20 association of southeast New Mexico and the Las Cruces home

3 WHEREAS, the New Mexico home builders association has
4 served a pivotal role in crafting the framework for the
5 Workers' Compensation Act to keep employer costs reasonable
6 while ensuring workers in New Mexico have a safe and reliable
7 pathway to return to work after a work-related injury; and

8 WHEREAS, the New Mexico home builders association has
9 worked to relieve the burden of double taxation in the
10 construction industry and remains the primary conduit for
11 gross receipts tax information to residential and commercial
12 contractors doing business in New Mexico; and

13 WHEREAS, the New Mexico home builders association
14 understands the need for affordability in the New Mexico
15 housing market and has encouraged the consideration of
16 affordability as a factor in the adoption of the state's
17 building and energy codes, in employing innovative
18 infrastructure financing paths and in crafting the Development
19 Fees Act;

20 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
21 REPRESENTATIVES OF THE STATE OF NEW MEXICO that February 18,
22 2025 be declared "New Mexico Home Builders Association Day" in
23 the house of representatives in recognition of the
24 organization's service and dedication to the housing industry
25 in New Mexico; and
