AN ACT

MAKING AN APPROPRIATION TO FUND THE ALBUQUERQUE TECHNICAL-
VOCATIONAL INSTITUTE CENTER FOR ADVANCED TECHNOLOGY TRAINING IN
THE CITY OF ALBUQUERQUE LOCATED IN BERNALILLO COUNTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Six hundred twenty-five
thousand dollars (\$625,000) is appropriated from the general
fund to the governing board of the Albuquerque technical-
vocational institute for expenditure in fiscal year 1997 for the
purpose of funding the Albuquerque technical-vocational
institute center for advanced technology training in the city of
Albuquerque located in Bernalillo county. Any unexpended or
unencumbered balance remaining at the end of fiscal year 1997
shall revert to the general fund.
