MAKING AN APPROPRIATION FOR A JUVENILE FORENSIC EVALUATION
PROGRAM IN THE THIRD JUDICIAL DISTRICT COURT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Forty-nine thousand dollars
(\$49,000) is appropriated from the general fund to the third
judicial district court for expenditure in fiscal year 1997 for
the purpose of establishing a juvenile forensic evaluation
program. Any unexpended or unencumbered balance remaining at
the end of fiscal year 1997 shall revert to the general fund.
