LOCATED IN RIO ARRIBA COUNTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Fifty thousand dollars
(\$50,000) is appropriated from the general fund to the office of
cultural affairs for expenditure in fiscal year 1997 for the
purpose of establishing and operating a narrow gauge railroad
museum in Chama located in Rio Arriba county. Any unexpended or
unencumbered balance remaining at the end of fiscal year 1997
shall revert to the general fund.
