MAKING AN APPROPRIATION FOR IN-PLANT DEVELOPMENT TRAINING

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Six million five hundred
thousand dollars (\$6,500,000) is appropriated from the general
fund to the development training fund for expenditure in fiscal
year 1997 for in-plant training programs conducted pursuant to
Section 21-19-7 NMSA 1978. Any unexpended or unencumbered
balance remaining at the end of fiscal year 1997 shall not
revert to the general fund.
