AN ACT

MAKING AN APPROPRIATION TO EASTERN NEW MEXICO UNIVERSITY FOR  
CURRICULUM DEVELOPMENT AND CULTURAL AWARENESS PROGRAMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Fifty-five thousand dollars (\$55,000) is appropriated from the general fund to the board of regents of eastern New Mexico university for expenditure in fiscal year 1997 for the purpose of curriculum development and cultural awareness programs to acknowledge the unique qualities of class, status, gender, race, disability and ethnicity. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
