AN ACT

MAKING AN APPROPRIATION TO FUND THE YOUTH ENRICHMENT PROGRAM AT THE UNIVERSITY OF NEW MEXICO IN BERNALILLO COUNTY; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --One hundred seventy-nine thousand dollars (\$179,000) is appropriated from the general fund to the board of regents of the university of New Mexico for expenditure in fiscal years 1996 and 1997 for the purpose of funding the African-American student services youth enrichment program, including personnel, administrative, travel and supplies expenses, at the main campus of the university of New Mexico in Bernalillo county. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
