AN ACT

MAKING AN APPROPRIATION FOR A STUDY FOR SANTA FE'S FORTY-YEAR WATER USE PLAN; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--Three hundred thousand dollars (\$300,000) is appropriated from the general fund to the office of the state engineer for expenditure in fiscal years 1996 and 1997 for the purpose of studying recoverable ground water availability for the city of Santa Fe's forty-year water use plan, as required by Section 72-1-9 NMSA 1978. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately. . 110809.1
