AN ACT

MAKING AN APPROPRIATION TO EXPAND AND ENHANCE PROGRAMS AT THE  
AGRICULTURAL SCIENCE CENTER IN THE CITY OF FARMINGTON.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. Two hundred thousand dollars (\$200,000) is appropriated from the general fund to the board of regents of New Mexico state university for expenditure in fiscal year 1997 for the purpose of expanding and enhancing programs at the agricultural science center in the city of Farmington. The appropriation shall be distributed by the board of regents in the following manner:

(1) thirty thousand dollars (\$30,000) to the cooperative extension service; and

(2) one hundred seventy thousand dollars

1 (\$170,000) to the agricultural experiment station.

2 B. Any unexpended or unencumbered balance remaining  
3 at the end of fiscal year 1997 shall revert to the general fund.
