AN ACT

MAKING AN APPROPRIATION TO THE ALBUQUERQUE PUBLIC SCHOOLS TO
STUDY THE FEASIBILITY OF INSTITUTING AN ACADEMY PROGRAM AT THE
MIDDLE SCHOOL LEVEL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Seven thousand five hundred
dollars (\$7,500) is appropriated from the general fund to the
state department of public education for expenditure in fiscal
year 1997 to fund a study of the feasibility of implementing an
academy program at the middle school level of public education
in the Albuquerque public schools. Any unexpended or
unencumbered balance remaining at the end of fiscal year 1997
shall revert to the general fund.
