AN ACT

MAKING AN APPROPRIATION FOR COMPUTER AND VIDEO TECHNOLOGY FOR
MESA VISTA CONSOLIDATED SCHOOLS IN RIO ARRIBA COUNTY; DECLARING
AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. One million three hundred thousand dollars
(\$1,300,000) is appropriated from the general fund to the state
department of public education for expenditure in fiscal years
1996 and 1997 in the following amounts for the following
purposes:

(1) eight hundred thousand dollars (\$800,000)
to purchase and install computer technology at Ojo Caliente
elementary school and Mesa Vista middle and high schools in Rio
Arriba county; and

(2) five hundred thousand dollars (\$500,000) to purchase and install video and computer technology for each classroom within Mesa Vista consolidated schools located in Rio Arriba county.

B. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY. --It is necessary for the public peace, health and safety that this act take effect immediately.
