AN ACT

MAKING AN APPROPRIATION FOR A STUDY TO UPGRADE THE COUNTY-WIDE RADIO COMMUNICATIONS SYSTEM OF DONA ANA COUNTY; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--Sixty thousand dollars (\$60,000) is appropriated from the general fund to the local government division of the department of finance and administration for expenditure in fiscal years 1996 and 1997 for the purpose of planning and engineering the upgrade of a county-wide radio communications system for the county of Dona Ana. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
