AN ACT

MAKING APPROPRIATIONS FOR CERTAIN STATE AGENCY PROJECTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Eight hundred thousand dollars (\$800,000) is appropriated from the general fund to the legislative council service for expenditure in fiscal year 1997 for the purpose of remodeling sections of the state capitol to increase the number of permanent staff offices with windows and to install shower facilities in the men's and women's third floor bathrooms. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.

Section 2. APPROPRIATION. --Two million dollars (\$2,000,000) is appropriated from the general fund to the administrative office of the courts for expenditure in fiscal

1 year 1997 for the purpose of implementing court automation  
2 projects statewide. Any unexpended or unencumbered balance  
3 remaining at the end of fiscal year 1997 shall revert to the  
4 general fund.

5 Section 3. APPROPRIATION. -- One million dollars  
6 (\$1,000,000) is appropriated from the general fund to the  
7 energy, minerals and natural resources department for  
8 expenditure in fiscal year 1997 for maintenance, repair and  
9 improvements to state parks throughout New Mexico. Any  
10 unexpended or unencumbered balance remaining at the end of  
11 fiscal year 1997 shall revert to the general fund.
