AN ACT

MAKING AN APPROPRIATION FOR ELEMENTARY AND SECONDARY PUBLIC
SCHOOL ECONOMIC EDUCATION INSTRUCTION AND TEACHER TRAINING IN THE
ALBUQUERQUE PUBLIC SCHOOL SYSTEM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--Fifty thousand dollars (\$50,000) is appropriated from
the general fund to the state department of public education for expenditure in fiscal year 1997
for the purpose of providing elementary and secondary public school economic education
instruction and teacher training in the Albuquerque public school system. Any unexpended or
unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
