AN ACT

MAKING AN APPROPRIATION TO THE ADMINISTRATIVE OFFICE OF THE COURTS FOR THE PURPOSE OF PROVIDING STATE MATCHING FUNDS FOR A FEDERAL GRANT TO FINANCE IMPLEMENTATION OF NECESSARY CHANGES IN JUDICIAL PROCEEDINGS RELATED TO CHILD ABUSE, CHILD NEGLECT, FOSTER CARE AND ADOPTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Forty-one thousand five hundred sixty-three dollars (\$41,563) is appropriated from the general fund to the administrative office of the courts for expenditure in fiscal year 1997 for the purpose of providing state matching funds for a federal grant to finance implementation of necessary changes in judicial proceedings related to child abuse, child neglect, foster care and adoption. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997
