AN ACT

RELATING TO CAPITAL EXPENDITURES; MAKING AN APPROPRIATION TO FUND A
VIOLENCE- AND ABUSE-REDUCTION PROJECT; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--One hundred fifty thousand dollars (\$150,000) is appropriated from the general fund to the state department of public education for expenditure in fiscal years 1996 and 1997 for the purpose of continued funding of a project that has been designed to reduce violence to and abuse of children by increasing community involvement. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
