AN ACT

MAKING AN APPROPRIATION TO THE CHILDREN, YOUTH AND FAMILIES
DEPARTMENT TO PROVIDE OR CONTRACT FOR CERTAIN SERVICES FOR
YOUTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. Ninety thousand dollars (\$90,000) is appropriated
from the general fund to the children, youth and families
department for expenditure in fiscal year 1997 to provide or
contract for services for youth in the following amounts for the
following purposes:

(1) forty-five thousand dollars (\$45,000) for a
health hotline resource and referral program and service; and

(2) forty-five thousand dollars (\$45,000) for a
program of entrepreneurship and leadership.
