AN ACT

MAKING AN APPROPRIATION TO PROVIDE TECHNICAL ASSISTANCE TO DEVELOP  
A POTATO PROCESSING PLANT IN SAN JUAN COUNTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--One million dollars (\$1,000,000) is appropriated from  
the general fund to the economic development department for expenditure in fiscal year 1997  
for the purpose of providing technical assistance to the Navajo agriculture products industries  
to develop a plant to process potatoes into french fries and other potato products. Any  
unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to  
the general fund.
