The 4 proceeds from the sale of the bonds are appropriated to the 5 6 state department of public education for the purpose of repair and renovation, including design, development and foundation 7 preparation, of Kiva auditorium at West Mesa high school on the 8 9 west side of Albuquerque located in Bernalillo county. Anv 10 unexpended or unencumbered balance remaining at the end of 11 fiscal year 1999 shall revert to the severance tax bonding fund. 12 If the state department of public education has not certified 13 the need for the issuance of the bonds by the end of fiscal year 14 1998, the authorization provided in this section shall be void. Section 2. EMERGENCY.--It is necessary for the public 15 16 peace, health and safety that this act take effect immediately.
